APPLICATION DEADLINE

Applicants must deliver a single, bound or stapled completed printed copy of this application form and supporting documentation, along with two recommendation letters, in a sealed envelope to the following ADDRESS:

Rafael Bernabeu Social Welfare Foundation. Avenida Albufereta N° 31, Alicante 03016 (delivered or posted with a postmark no later than 40 days prior to the jury's decision for this edition)

Applicants must simultaneously send A SINGLE PDF DOCUMENT file containing the completed application form and supporting documentation. The file must be named using the applicants name and surname and sent to the following E-MAIL ADDRESS: becasfundacion@institutobernabeu.com

Applications who do not meet the requirements indicated above may be excluded from the selection process.

GENERAL CONDITIONS

- Scholarships are open to young people under the age of 35 who are currently studying, or have been accepted to study, in Spain.
- Applicants may only apply for one scholarship and two or more scholarships may not be awarded to the same person.
- Successful candidates awarded a Rafael Bernabeu Social Welfare Foundation scholarship commit to putting their utmost into their studies.
- Scholarships may be withdrawn if the candidate is found to have falsified the supporting documentation that led to the award of the scholarship.
- The Foundation's scholarships are compatible with other scholarships awarded by other organisms that are not related to the Foundation and for which candidates may have applied.
- Scholarships amount to €2,500 per student.

THE SELECTION PROCESS

- The Foundation will carry out a pre-selection process taking into account if applications meet the terms and conditions of the scholarships and eliminating any applicants who do not meet the criteria.
- Following this, a Selection Committee will assess the candidates and may choose to interview pre-selected candidates in order to evaluate their suitability in terms of personal background, academic background, interests, integrity and the future prospects of their studies.
- The Selection Committee's decision will be final, may not be contested, will be confidential and will bring the selection process to a close. The decision will be made public before the end of the month prior to the scholarship award ceremony. This will be the only source of information and no correspondence regarding the decision will be permitted. A scholarship or scholarships may be withdrawn based on Selection Committee criteria.

MONITORING SCHOLARSHIP HOLDERS

Scholarship holders must hand in a Completion Report indicating the subjects and activities, participation in projects, assignments and so on that he/she undertook as he/she enjoyed the benefits of the scholarship.

ABSENCE OF A CONTRACTUAL LINK

Award and receipt of a scholarship does not, under any circumstances, imply a contractual, employment or statutory relationship with the Rafael Bernabeu Social Welfare Foundation, nor with any associated entities.

DATA PROTECTION

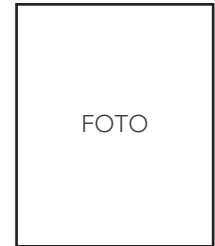
